The Parish Council's website has been running for a few years and hosts policy documents, financial statements, minutes and agendas of previous Parish Council meetings. A new Facebook has been started by one of our Councillors and this can provide quick reactions to problems in the Parish.

- Try to find ways to encourage parishioners to attend its meetings so that they
 are able to see how the Council operates and understand the decision making
 process
- Continue to reviews its website and social media accounts and investigate ways to improve and enhance them
- Continue to review its policies and procedures to ensure that it is run in a legal and business like manner

HOW WE WORK

As well as holding monthly meetings (the secondTuesday of the month in the URC schoolrooms at 7.30pm unless stated otherwise on the agenda) to discuss all matters relating to the village, the Parish Council also has a number of key areas that are looked at by individual Councillors and reported back at each meeting. They have no power to make decisions and must report back to the Council for the Council to further consider their recommendations.

OUR FOUR YEAR PLAN

These focused committees and councillors with key areas of responsibility discuss monthly and agree actions to be taken. These actions may be reactionary such as fixing a bench or attending to a bus shelter, or they may be strategic and relate to projects for the future improvement of the village.

Reactionary actions are resolved at our monthly council meetings but our strategic objectives require more planning.

The business plan sets out our strategic objectives during the next four years.

STRATEGIC OBJECTIVES

At a high level, our strategic objectives can be defined as:

- To help create a socially inclusive, caring and economically viable community which embraces all its residents irrespective of age, culture, income, race, gender, sexual orientation or religion and which seeks to develop their wellbeing, knowledge, understanding and mutual cooperation.
- To provide high quality, efficient, cost-effective and sustainable services.
- To promote and encourage the provision of a range of leisure, social, recreational an community facilities in the parish
- To provide a channel for the views and expressions of the local community and to be responsive to its needs and aspirations
- To develop partnership and agency working with public and private sectors in terms of resources and finance for the benefit of the community
- To liaise with and support local community associations
- To develop partnerships with residents, local businesses and local organisations
- To develop council meetings as a method of public engagement

- To improve the Parish Council's role within the local community
- To be an advocate for local residents and business and to address local issues.

To meet these objectives we need to identify specific projects and areas for improvement. Some of our specific objectives for 2021 – 2025 are:

- To seek the opinion of village residents about any areas that they would like to see prioritised and developed by way of a questionnaire to each household e.g new Village/Sports Hall
- To continue to work with the Linear Village Green working group to enhance the centre of the village following the bypass
- To advance plans for traffic calming in the village
- To compile and maintain an emergency plan for the parish in the format required by the County Council Emergency Planning Officer including an Emergency Flood Plan
- To encourage and help to develop more facilities for all ages
- To ensure that Councillor attend training courses to keep them up to date with the law and best practice
- To consider planning applications in the parish and to comment accordingly, in line with general planning policy and the Neighbourhood Development Plan
- to report any planning or environmental infringements to the appropriate authority
- To pursue the possibility of purchasing the car park at the White Hart if the opportunity arose
- To locate suitable land for a community facility.
- To start reviewing the Flore Neighbourhood Plan.
